

Target Market Determination Funds Management

This Target Market Determination (TMD) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). It sets out the class of consumers for whom the product (and the particular investment options available under the product), including the key attributes of the product would likely be consistent with their likely objectives, financial situation and needs. Any reference to product in this TMD includes a reference to the particular investment options or choices offered under it and the TMD has been prepared on that basis. In addition, the TMD outlines the triggers to review the target market and certain other information. It forms part of Melbourne Securities Corporation Limited (ACN 160 326 545, AFSL 428289) (MSC) and Cache Investment Management Pty Ltd's design and distribution arrangements for the product.

This document is not a product disclosure statement and is not a summary of the product features or terms of the product and the particular investment options offered under it.

This document does not take into account any person's individual objectives, financial situation or needs. Target Market Summary for the Unhedged Product (The Product)

The Unhedged Product is made up of particular investment options (or choices).

Each of the Investment Options are addressed in this TMD.

The Investment Options

Industrial Activity

This investment option is likely to be appropriate for a consumer who seeks adjusted market exposure to equity and bond asset classes, depending on whether the US economy is expanding or contracting.

This investment option can be used to gain exposure to:

- (a) International equities
- (b) International bonds; and
- (c) Cash (USD and AUD).

This investment option is designed to be used within a portfolio where the consumer has a 7 year plus investment timeframe, high risk/return profile and may need infrequent access to capital.

Sector Rotation:

This investment option is likely to be appropriate for a consumer who seeks to allocate between equity and bond exposures according to market conditions.

This investment option can be used to gain exposure to:

- (a) International equities
- (b) International bonds; and
- (c) Cash (USD and AUD).

This investment option is designed to be used within a portfolio where the consumer has a 7 year plus investment timeframe, high risk/return profile and may need infrequent access to capital.

Momentum:

This investment option is likely to be appropriate for a consumer seeking to gain exposure to an identified set of stocks within the Russell 3000 universe that has demonstrated the most directional movement over a defined period.

This investment option can be used to gain exposure to:

- (a) International equities
- (b) International bonds; and
- (c) Cash (USD and AUD).

The investment option is designed to be used within a portfolio where the consumer has a 7 year plus investment timeframe, high risk/return profile and needs infrequent access to capital.

USD Cash

This investment option is likely to be appropriate for a consumer seeking to preserve capital by holding USD cash in a USD bank account.

The investment option may be used to gain exposure to USD cash.

The investment option is designed to be used within a portfolio where the consumer has no minimum timeframe, low risk/return profile and may require immediate access to capital.
